This is for information of all concerned that for processing / declaration of results by District Examination Committee of Annual Examination of class IX and Pre-Board Examination of class X, the weightage to be taken for 6 (six) subjects having IA marks i.e . **English, Mathematics, Science, Social Science, Advanced Mathematics and Geography**-- details are as given below :

	Unit Test 1	Half Yearly	Unit Test 2	Annual/Pre-Board	Total
For Theory	20% of 45 = 9	30% of 90= 27	20% of 45 = 9	50% of 90 = 45	90
For IA	20% of 5 = 1	30% of 10= 3	20% of 5 = 1	50% of 10 = 5	10
Total	10	30	10	50	100

For the Subjects, other than the above 6 subjects, the detailed breaks-up are as follows:

1. **Unit Test 1 + Unit Test 2**:: 50+ 50 Marks (including Practical) --- **20%** weightage to the Annual/ Pre-Board Exam.
2. **Half Yearly**:: 100 Marks (including Practical) --- **30%** weightage to the Annual/ Pre-Board Exam.
3. **Annual/Pre-Board**:: 100 Marks (including Practical) --- **50%** weightage to the Annual/Pre-Board Exam.

The mark sheets of the Unit Tests, Half Yearly and Annual (for class IX) and Pre-Board Examination (for class X) have to be uploaded in SEBA's portal by the school concerned immediately after the evaluation. The Answer scripts of all candidates appeared in Unit Tests and Half Yearly Examination are to be shared with students and parents. They must know about the mistakes committed by the students.

Further, for the Academic session 2022-23, it is notified that for Unit Test, Half yearly and Annual Examination of class IX and Unit Test, Half Yearly, Pre-Board and HSLC Examinations of class X, the question papers of the subjects **English, Mathematics, Science and Social Science** will contain 50% objective type and 50% descriptive questions.
